

2017 Caribbean Industry Report After declines in 2016, hurricanes temper 2017 growth

The last few years have been relatively strong for the Caribbean hotel industry. However, the region has seen its fair share of setbacks from the Zika virus scare of 2016, to weakened European demand as a result of Brexit and the recent stretch of devastating hurricane activity during an already slow part of the year.

Results from 2016 showed decreases in each of the three key performance Indicators (KPIs). Occupancy in the region dropped 2.3% to 66.6%—a few percentage points behind where it had been over the previous few years. Average daily rate (ADR) held better, at the second-best level of the last 10 years, but still dropped 0.5%. As a result, revenue per available room (RevPAR) was down 2.8% in 2016.

Through August of 2017, the Caribbean showed slight increases across those same KPIs. Occupancy was up 0.7%, ADR rose 1.2% and RevPAR increased 1.9%. The September year-to-date data shown below reflects the negative effects of the massive hurricanes that hit the region last month. RevPAR decreased for the month by 16.6%, which largely contributed to year-to-date decreases. As of September, however, occupancy was the only KPI to show a decrease, down 0.9%. ADR was up 1.2%, which drove overall RevPAR growth of 0.8%. Supply was up to 2.8% overall, largely from the long-awaited opening of the Grand Hyatt Baha Mar in April. Demand for the month of September was down 15.1%, but year-to-date demand was up 1.9%.



Caribbean RevPAR Cycle

The graph below displays the RevPAR cycle from January 2010 through August 2017 on a trailing 12-month basis. The Caribbean experienced consistent RevPAR gains from 2014 through 2016 with a peak in January of last year. Since that peak level, rates and occupancy have declined somewhat, but have remained strong overall. Considering the impact of Hurricane Irma and Hurricane Maria, declines in both rate and occupancy are likely to continue moving forward.






Key points from STR's Caribbean hotel industry data:

- Only 34% of the Caribbean hotels that reported HOST P&L data experienced an increase in rooms revenue.
- The Turks & Caicos Islands remained the RevPAR leader in the region for the August 2017 YTD time period with a RevPAR level of US\$652, followed by the Cayman Islands with RevPAR at US\$261.
- As of August 2017 YTD, only five of the islands showed RevPAR increases. Jamaica led YTD RevPAR growth at 9.1%, while St. Lucia showed the largest decrease of 15.2%.
- 2016 labor costs increased 11.8% overall in the region, with the largest increases coming in Administrative and General, Rooms and Marketing categories.
- Utility costs have continued to decrease in the region over the previous two years, including an 8.6% decline in 2016.
- Jamaica leads the region in hotel projects in the pipeline with more than 3,500 rooms, followed by the Dominican Republic with 1,948 rooms.


2017 YTD August - RevPAR Positioning Matrix: Caribbean Region by Country

Looking solely at September RevPAR change by island, you can see how each island was affected by the hurricanes. Some of the other tourist destinations also saw substantial RevPAR decreases. The Bahamas saw a decrease of 37.3%, St. Lucia saw a decrease of 33.1%, and the Dominican Republic saw a decrease of 25.1%.




2017 Sept YOY STAR Data


Last year was less profitable than previous years for the Caribbean region. In examining 2016 HOST P&L data on a same-store, per-available-room (PAR) basis, total revenue declined 4.5%, which led to a gross operating profit (GOP) loss of 9.3%. Departmental expenses grew slightly, but undistributed expenses declined 6.6%. The industry did see some growth in the Other F&B category (+16.7%), which is a positive indicator for group demand, and in Miscellaneous Income (+4.5%).
