Coronavirus Disease (COVID-19) Pandemic

Summary


This is an update to the CARPHA Situation Report published on May 8, 2020, in relation to the outbreak of COVID-19.

To date, there are 16,561 cases in 33 countries/territories (including 24 CARPHA Member States), in the Caribbean Region. The risk of further importation of cases to the rest of the Caribbean remains **Very High**.

The Regional Coordinating Mechanism for Health Security (RCM-HS), continues to work with Heads of Government and key partners on a region-wide approach to the COVID-19 response. At this time, much of the current focus centers around developing and implementing national strategies for a phased lifting of restrictions in CARPHA Member States, while ensuring that appropriate social distancing measures are maintained for continued population safety.


SITUATION UPDATE

COVID-19 in the Caribbean

Since the previous report on May 11, 2020, an additional 1,553 cases of COVID-19 were confirmed in 15 countries within the Caribbean, bringing the region's total confirmed cases to 16,561 in 33 countries/territories. This new total represents a 10% increase in the number of confirmed cases. There were 704 deaths recorded in the Caribbean region as at May 11, 2020.

COVID-19 SURVEILLANCE AND EPIDEMIOLOGY



As of May 11, 2020, the WHO reported 4,006,257 cases of patients with COVID-19. A total of 215 countries, areas or territories have confirmed at least one case among travellers exposed while abroad and/or person-to-person contact.

No new countries reported their first confirmed case of COVID-19 since the last Situation Report on May 8, 2020. Figure 1 shows a breakdown of cases by Region.

ANALYSIS OF CASES AMONG CARPHA MEMBER STATES

As of May 11, 2020, there have been 1,651 cases confirmed from CARPHA Member States (CMS), the highest number was reported on April 15, 2020. (Figure 2).

This chart is based on information posted on Ministries of Health official websites, and numbers may vary based on the time information is posted.





Figure 3. Reported confirmed cases of COVID-19 by age group in CMS, n=259

For the cases for which data was available, the majority were aged 50 years and over, with 50-59 being the modal age group. There was no age reported for the majority of cases which have been excluded from this chart (Figure 3).

Figure 4. Percentage of Confirmed Cases of COVID-19

Among cases for whom sex was reported, 56% were female and 44% were male. (Figure 4).




Figure 5. Percentage of Confirmed Cases of COVID-19 by source of transmission in CMS

Among cases for whom a source of infection was reported, 28% were imported; and 53% appeared to be close contacts (local transmission) of a known imported case (Figure 5).




Figure 6. Category of Countries by Transmission Classification

Among the 24 Member States, 58% (14/24) have been classified as having sporadic cases; and 42% (10/24) have reported clusters, based on data received by WHO from national authorities by 10:00 CEST, May 10, 2020^{1} (Figure 6).

Laboratory

Since February 10, 2020 and as of May 10, 2020, CARPHA has received 3,717 samples from 16 CMS, 421 (11.3%) of which have tested positive since the start of the outbreak, 249 results (6.7%) correspond to new cases




Figure 7. COVID-19 Progression in CMS*. Laboratory Confirmed New Cases. Feb-May

Figure 7 shows the progression of COVID-19 cases which have been confirmed in CMS from February – May 2020.

CARPHA's COVID-19 Testing Process and Adherence to Quality Standards

The CARPHA Medical Microbiology Laboratory (CMML) currently tests all suspected cases of COVID-19, as per the WHO case definition, provided by the WHO Global surveillance for COVID-19 caused by human infection with COVID-19 virus. T

The CMML uses the WHO recommended **Polymerase Chain Reaction (PCR) method**. This method remains the gold standard for COVID-19 laboratory diagnosis because the sensitivity and specificity of the test are nearly 100%. <u>Read more</u>. Video: <u>The CARPHA COVID-19 Test-ing Process</u>

CARPHA's Technical Cooperation

Personal Protective Equipment (PPE) Training for Law Enforcement Officers: On May 7, 2020, CARPHA in collaboration with the CARICOM Implementation Agency for Crime and Security (IMPACS) conducted a training session, "Use of PPE for Frontline Security Officers" targeting law enforcement officers (police, customs, coast guard, immigration, military and prisons) in CARICOM Member States responsible for ports of entry and investigations. The training was facilitated through the Caribbean Basin Security Initiative virtual platform, CBSI-Connect and the Trinidad and Tobago Police Training Academy.

The topics included an "Introduction to COVID-19 – The Pandemic" (Dr. Stephanie Fletcher-Lartey, Consultant HCE), the main session on the use of Personal Protective Equipment (Ms. Sacha Wallace-Sankarsingh, Biorisk Manager) and information on Wellbeing Measures for Security Frontline Workers (Dr. Tamu Davidson, Head, CDI).

More than 500 law enforcement professionals from across 20 CARPHA Member States (15 CARICOM Members and 5 Associate States) attended the virtual session in addition to other regional organizations - the OECS and the RSS. Participants were from 17 countries including Anguilla, Antigua and Barbuda, Bahamas, Barbados, Belize, Bermuda, Cayman Islands, Dominica, Grenada, Guyana, Haiti, Jamaica, St. Kitts, St. Lucia, St. Vincent and the Grenadines, Suriname, Trinidad and Tobago. The largest contingent being from Jamaica (126). Trinidad and Tobago had 5 virtual classrooms as well as 60 individuals signed on to the virtual training.

The session has been dubbed to be one of, if not the most subscribed session held on the platform. CARPHA continues to collaborate with CARICOM IMPACS to strengthen preparedness and response on the frontline.

- May 9, 2020: Dr. St. John and Dr. Indar participated in the meeting "Consultations with Labour and Private Sector Leaders" to solicit input from labour and private sector leaders to on proposed protocols for re-opening of the Caribbean to travel

NEWS AND INFORMATION UPDATES

• May 7, 2020: In a statement released by the CARICOM Secretariat at the *Tenth Special Emergency Meeting of the Conference* of *Heads of Government of the Caribbean Community (CARICOM)* which took place on May 5, 2020, Heads of Governments within the region along with representatives from CARPHA, the University of the West Indies (UWI) and the Caribbean Disaster

Emergency Management Agency (CDEMA) discussed harmonizing responses and policies on the impact of COVID-19. Included in the discussion was the approach to re-opening ports of entry and the need for the development of a common public health policy and protocols which CARPHA will assist in drafting.
