It should be noted that the exemption for pregnant women is removed given that several COVID-19 vaccines are now approved for use in pregnancy.		Unvaccinated visitors who have been granted a medical exemption will be required to apply on the entry portal, test on arrival, quarantine for five days, and receive a negative test result to exit quarantine.
